Shame Napthine Government

The RTBU has recently put together a public transport budget submission which has been handed to both the

State Government and the Opposition. This paper is what the RTBU consider to be the priority program for infrastructure and service investment in Victoria's public transport system.

We take into account the high increase in patronage levels over the last decade which has put Victoria's public transport system under extreme pressure. This pressure combined with projected increases in patronage, population growth, and urban sprawl will equate to a system that will not cope with the demands placed on it unless further investments are made. Funding needs to be allocated to the four key areas of rolling stock, infrastructure and customer service across the metropolitan train, tram, the regional rail networks as well as rail freight.

The Napthine state government has recently announced just over \$2 Billion over 5 years for a number of projects including investment in the Pakenham corridor but the Napthine announcement falls dramatically short not only in financial terms but also largely when looking at the difficulties that the system will face in the future on the metropolitan, regional and freight systems.

There is no mention at all of funding for the Metro rail link, but then this should be no surprise to members as the Abbott federal government has washed its hands of any funding for state based public transport systems.

Both the Napthine and Abbott governments need to commit serious long term funding to address the issues raised by the RTBU.




Failure to do so will only mean that future governments will face a near 'Hurricane' task in righting the wrongs of the current seat warmers in both state and federal parliament.

The RTBU will continue to lobby both the state government and the opposition as we believe that it is vital to fight for additional funding. Unless these measures are put in place quickly, public confidence in service reliability, customer service, safety and security will fade away.

Station Proposition Update

Recently Metro took major steps to fix the massive problems inside the Station grade caused by the Station Proposition linked

with attempts to ram proposed new rosters down station staffs throats.

Following those changes Union officials and representatives from Metro met to begin building a process that would enable a new roster to be built that took in the concerns from individual stations. This included a set of guidelines and the parameters that would form the basis for changes moving forward.

We still face the rather larger problem of the so called "Merit List" which affects many RTBU members working in the station area. The Merit List needs to be scrapped and any positions that become vacant following the finalised station proposition should be advertised and filled in the normal way.

Metro Management has agreed to a meeting late this week to discuss this most pressing issue. Let's hope that once again common sense will prevail and Metro will change its current practice.
