


I am proud to also announce that the incumbent RTBU National Secretary, Bob Nanva was reelected unopposed.

## With Metro it is all about the bottom line

Several months ago members started to hear murmurings of vehicles being evaluated and potentially removed The RTBU investigated the rumours and was met with a response that definitively stated before any such

moves were to be made there would be proper and thorough consultation with a timeline of a few weeks set.

On the 28th of November the RTBU received a letter stating that at this stage 25 members will be

losing access to their vehicles for the purposes of commuting to and from work. Considering the majority of these members were offered the vehicles during their interviews and subsequent appointment to their roles, and the fact that they **hold letters signed off by management authorising them to commute and store the vehicles at the place of residence** the RTBU feels the removal of these vehicles without discussion of compensation or alternative arrangement is outrageous and has subsequently put the matter into dispute alongside the ETU and Professionals Australia.

The RTBU has requested a list of affected members and awaits Metro's response.

Meetings will be held with affected members as more information comes to light.

This is another example of the company trying to take our members for a ride.

The RTBU will not stand for this.

## Back pay win for part-time station members

The RTBU (Rail Divisions) recently had a major win against Metro Trains in relation to the payment of overtime to part-time station members covered by the Metro Trains

Melbourne Pty Ltd Rail Operation's Enterprise Agreement 2012-2015 (EA).

Late last year, Metro attempted to climb through a loophole in the EA, using the 48 hours notice provision for change of roster to short change part-time members.

Whilst the RTBU has been in discussion with Metro Senior Management since the departure of Sean

Ellis, these discussions proved to be fruitless and we were left with no choice but to escalate the dispute to the Fair Work Commission (FWC).

During the Fair Work Commission Conference before Commissioner Lee, Metro agreed moving forward to stop abusing the notification of change provision in the EA and start paying overtime for hours worked in excess of your daily rostered shift, irrespective of whether 48 hours notice is provided.

On the question of back pay, Metro originally baulked at the idea, however following discussions with the RTBU post the FWC appearance, they reluctantly agreed to back pay affected members.

In order to speed up processing of back pay claims for unpaid overtime, it has been suggested

that members may calculate, with the assistance of their Station Master/Supervisor, the overtime hours worked in excess of their daily rostered hours since September 2013. Your Supervisor will then forward those details onto your paymaster where they will be checked and payment processed.
