WOMEN MAKE THE UNION STRONG

International Women's Day this year saw Trades Hall championing the theme of Safe, Respected and Equal. I was very proud to be a part of the RTBU contingent at the rally.

International Women's Day Rally has a long history of celebrating women's achievements and highlighting the current campaigns of the movement in the fight for equality for all. This couldn't be more relevant to an industry like ours.

This year, Trades Hall kicked off the campaign to end sexual harassment at work and ban non-disclosure agreements (NDAs). NDAs are commonly used by bosses to settle individual matters by stopping members and the union from being able to speak out publicly about the matter at hand.

This often means members are unable to speak openly and plainly about their experience, or draw broader public awareness to how an issue has been dealt with.

To ensure that the voices of survivors are heard, and that perpetrators are held to account unions are calling on the State Government to legislate restrictions on the use of non-disclosure agreements to ensure workers are empowered to speak out without fear of retribution or reprisal. The RTBU has a long and proud history of achieving wins for women in a male dominated workforce from basic needs like toilets, to domestic violence leave and the gendered violence clause in all major enterprise agreements.

It is crucial to recognise that the fight for women's rights is not solely a women's issue, but a universal one. Unless we protect our most vulnerable, lowest paid or least protected, it is difficult to achieve improvements across the board. Solidarity on common equality is our strength!

As history tells us, pay equality, the superannuation gap, parental rights, flexible work arrangements and better work life balance stands to benefit not just women, but all workers. We must stop employers' attempts to divide and conquer or pay lower than the rightful entitlements based on gender to advance the standing of all rail and public transport workers.

RTBU Women Fight & Win

For women working in a male dominated industry, many feel as though they must work twice as hard to have their voices heard. The RTBU Women's committee was set up 13 years ago to encourage women to become more active in their union, discuss women's issues openly and frankly, and press forward on addressing issues that remain unresolved by employers to this day.

To inspire more involvement, an annual Women's Conference is held to celebrate the achievements of women in our industry and plan for the future.

This conference will be an opportunity to network with other Members, share experiences, and develop activists' skills.

SAFETY IS ALWAYS ON THE AGENDA

Safety at work continues to be a key priority of the RTBU.

We have met with stakeholders regarding strengthening safety measures against assaults, better using data and increasing public awareness through advertising campaigns.

As Delegates, HSRs, and Members we must maintain the pressure on companies to provide meaningful data on assaults across the network, to not only listen but consult thoroughly with Members to implement concrete solutions.

A big part of this is reporting. Members must make sure they report all incidents, no matter how big or small. This enables all involved to access the support they need and so that we have accurate data on the prevalence and nature of workplace assaults in our industry.

It cannot be considered "just a part of the role" to go to work and face abuse. As a union, we must

use our collective voice to ensure that employers uphold their duty of care to provide a safe workplace for all frontline workers who keep the network running every day.

There is a long road ahead as we look to overhauling companies' attitudes and responses towards assaults on the network. However, just as the RTBU Members of the past have paved the way for the conditions we have today, we will keep up the fight for an industry where no one has to feel unsafe and unsupported at work.

Over the last few years, we have engaged with OH&S reps to be part of the safety campaign, ensuring that Members are consulted and represented every step of the way. HSRs have been integral to our wins so far, such as successfully lobbying Metro to properly staff stations, resisting their attempts to drive profits at the expense of the safety of all frontline workers. The RTBU will continue to provide training for HSRs, giving them the skills to lead the fight as advocates for the physical and psychological health and safety of their fellow workers. Put your hand up when HSR, Delegate and Women's Advocate elections are being held for your workgroup, encourage fellow members to put their hands up and contribute your ideas and passion to this campaign and so many more. 
