# V/LINE STRIKE HITS STRONG!

In a show of strength, members across V/ Line operations brought the network to a halt on Wednesday to advance claims in EA negotiations.

The action saw stoppages between 3am-7am with consequences across the state into the afternoon.

Fed up with V/Line's poor management practices, members have sent a powerful message to V/Line bosses – WE run the network. Disrespect us at your peril!

The action had broad impact that has been felt where it matters most. Saturated media coverage across newspapers, radio and TV news reached all Victorian regions and even the national broadcasts as we told the story of RTBU members fighting for fairness at work.

V/Line have continuously refused to accept core union claims that tackle job security, work-life balance, and fairness of process across the organisation. Industrial action is the only language that they understand.

A big congratulations to all members involved directly in the action and those supporting the resumption of services after the action. You have made your first mark in the campaign to get what you deserve!

The RTBU will continue to stand with members as we push for the best possible agreement that ensures members get what they deserve. V/Line management have been put on notice; start making progress towards resolving members' major issues or we will escalate our campaign. Members have shown that they are disciplined in taking action.

RTBU bargaining representatives have made it clear to V/Line that they are willing and ready to bargain.

With growing patronage and major projects on the table, now is the time to lock in our conditions for the future.

**OJT MINIBUS ALLOWANCE WIN!** 

The RTBU has secured a victory for AOs across the V/Line network.

In October, V/Line abruptly announced that the allowance for Minibus actions would cease immediately.

RTBU disputed the lack of consultation around this change and the impact it would have in a time of increasing cost of living pressures.

Through the hard work of Delegates and Officials, we were able to secure the following for Authorised Officers at V/Line:

1. The On The Job Trainer (OJT) allowance will be paid as it was previously, back paid until 22 November. This represents four weeks

additional OJT allowance pay that we have secured for members.

- 2. Minibus initiative remains a voluntary addition to normal duties.
- З. All staff who attend a disruption that is classed as a "minibus call out" are to be paid the minibus allowance from the time they are called out to the time they return to their respective home bases
- Minibus call out is as per disruption, not 4 as per location. For example: for fatality, detraining may be one site with the actual replacement buses etc at a different site. If the minibus is called out for that disruption, AOs receive the allowance regardless of which location they attend.
- 5. If staff are recalled for a "Minibus callout", minibus payments will also occur for that call out
- 6. All previous safety related matters regarding minibus remain the same, with driver fatigue checks and, 2 AOs in the minibus whenever passengers are being transported with 1 V/ Line Incident Response Vehicle (VIRV) or other suitable work vehicle shadowing for safety (shadowing car must only have AOs).

updated on where the negotiations are.
